1. All photography & ceremony sessions are for outdoor areas ONLY (rain or shine), no exceptions.		
	For ceremonies: Capacity is limited to 20 people.	
2.	All vehicles MUST park in visitor parking lot (unless directed by Arboretum staff) and all visitors MUST	
	WALK to the desired photography & ceremony location.	
3.	Plant sensitive areas cannot be used for photography & ceremony session:	
	Woodland Garden and Breezy Island.
